
OUR HISTORY

This section of the newsletter is dedicated to the history of ancestors of members of this camp. This month, Johnny Moss provided information about his Confederate ancestors. Unlike Mr. Montgomery, Mr. Anderson, and Mr. Denmark (who are all real grandsons), Johnny is five generations removed from the War Between the States.

William E. Moss married and raised a family in the Sugar Creek area of Jackson County, Tennessee. Two of his sons, Reese V. Moss and James R. Moss were of the age to fight in the War for Southern Independence. They and their neighbors joined a company that was organized on 30 July, 1861 in Livingston, TN. This became Company G of the 25th Tennessee Infantry Regiment. Company G was composed of men from the Flynn's Lick region of Jackson County. Captains of Company G were Leonidas A. McCarver and Albert Green.

Overton County was the base of operations for the 25th TN. Camp Zollicoffer was the headquarters for the regiment as it was organized. Camp Myers was the training area for the men as they learned military order. During the early fall of 1861, the men of the 25th skirmished with federal units and home guards along the Kentucky border north of Overton County.

By January, 1862 the 25th was under the command of Brigadier General Felix Zollicoffer and was involved in the battle of Fishing Creek, KY (also known as Mill Springs and Logan's Crossroads). General Zollicoffer was killed in this battle when he mistakenly rode up to a federal unit to issue orders.

After Fishing Creek, the 25th moved down to Gainesboro, then over to Livingston, and then on to Murfreesboro. By May, 1862, the 25th was in Corinth, Mississippi and was under the overall command of General Patrick Cleburne. By October, 1862, the 25th was in the command of General Bushrod R. Johnson at the Battle of Perryville, KY.

Of interest, the 17th, 23rd, 25th, and 44th TN remained together the rest of the war as Johnson's Brigade. They marched 555 miles in sixty days during September and October, 1862. By December, 1862, Johnson's Brigade was again under the command of General Cleburne and fought in the Battle of Murfreesboro. They later fought at Chickamauga and ended the war in Virginia.

Reese V. Moss and James R. Moss survived the war. Their younger brother, Albert K. Moss became the ancestor of Dillard-Judd member Johnny Moss.
